- **3.21.1.** Fix the frequency band of 2.3 2.4 GHz and 3.3 3.4 GHz for Broadband Wireless Access system for now. To cancel the assignment of 2300 -2305 MHz frequency band assigned to M/s Personal Broadband Pvt. Ltd. to provide Internet Service using iBurst Technology as it has not yet used that technology to provide that service.
- **3.21.2.** Ask Nepal Doorsanchar Company Limited to vacate the Microwave Link frequency in the 2.5, 3.5 GHz frequency band and use the obtained band for Broadband Wireless Access system in future.
- **3.21.3.** Use Auction mechanism while distributing the above mentioned 2.3 and 3.3 GHz frequency band and prepare the descriptive working procedure for both the auctions.
- **3.21.4.** Distribute 90 MHz bandwidth in 3.3-3.4 GHz for Internet Service Providers (ISPs) and 100 MHz bandwidth in 2.3 GHz for existing Basic telephone/ Mobile telephone/ Rural telephone operators through auction.
- **3.21.5.** To allocate two slots of 5 MHz each in 3.3 GHz band to provide Internet in Rural areas on shared and Interference non-protection basis for Rural ISPs. Maximum EIRP to be 200mW. Waive Frequency fee for using that band.
- **3.22.** The following has been decided for the fixation of Microwave Link Frequency Band
 - **3.22.1.** To recommend Radio Frequency Policy Determination Committee to fix 6.4 7.1 GHz (upper 6 Ghz band) band in Telecom for Fixed Microwave Link.
 - **3.22.2.** The frequency fee the above mentioned frequency band shall be fixed as per the committee's decision dated 2062/8/21 B.S. for 7.5 GHz band.
- **3.23.** A committee has been formed to prepare guideline which fixes the standard and use of the Mobile towers and antennas as part of Radio Spectrum Management.
